A visit to Dr Töben, Saturday 29th August 2009

Yesterday (Saturday, 29th), three of Fredrick's friends, myself included, visited him at Cadell Training Centre. It was a two and a half hour drive to Cadell, which is located 180 km from Adelaide.

We arrived just before 2pm, running late as we had planned to arrive at 1pm. Upon arrival we entered the gates, parked our vehicle and went to the visitors office. We were met by quite friendly prison officers, and given a form to complete with our personal particulars, and identification. After checking this and our IDs, we had to place any keys or money in a locker provided and then have our bodies scanned with a hand held metal detector, after which we passed through the glass doors to the visitors area.

We were greeted by quite a pleasant surrounding, approximately 20 picnic style benches under some leafy gum trees. About 10 of these benches were occupied by varying groups of visitors, obviously family and friends. One of the guards had gone to inform the prisoner of our arrival, and after a couple of minutes we saw a figure approaching from the surrounding buildings. At first I was unsure if this was Fredrick. I had never seen him wearing Jeans!! He also looked much younger than the last time that I had seen him, on the day that he was imprisoned, 13th August, just over 2 weeks ago. At first Fredrick, displaying his particular sense of humour, pretended to have lost his mind and seemed to have been in a state of

consciousness reminiscent of someone who has had a frontal-lobotomy, and pretended not to know us. We all sensed that everything was fine, and after some very warm and emotional greetings, we all sat down at the nearby picnic table.

Fredrick told us all about his experiences at Yatala Prison where he had been for 2 weeks. In his words, "It was a character building exercise". Some of his experiences were obviously quite unpleasant, but he likened the whole thing to doing basic military training, or boarding school. He praised the guards of both prisons, telling us that they do a good job, and were working in very difficult environments.

Physically, Dr Töben was in fine shape. He told us that he had lost five and a half kilograms. He was a totally different picture from that of a few weeks ago, when the strain of being persecuted for over 13 years was starting to show its effect. He had been looking very tired, exhausted and ragged. Mentally, one could see that he was tight and strained. He had put on a little weight, which made his clothing seem a little too small for him. Now, he was beaming and looked to be at least 10 years younger than before. The rest was obviously doing him good. I still could not come to grips with his prison garb. Jeans that were rolled up at the ankles, obviously too long for him, a blue sloppy-joe and prison wind-cheater. It did not seem to fit his character at all. His usual attire is a smart suit. This is his usual all-purpose uniform, wearing it for all manner of occasions from picnics to the theatre, even bushwalking!

Fredrick shares a cell with another fellow, with whom he gets on well. They are locked in each night at 9pm and released again at 7am. There is a good library at the prison, and the food is good. This is a low security installation, but the discipline is still very strict. The prisoners know that it is very much a privilege to be there which can just as easily be taken away if they do not behave.

We spent the time discussing the events of the last few weeks. I passed on many greetings and wishes of support from his friends all around the world, and he wished me to pass on his thanks to all of his friends. At 10 to 4 one of the guards came and told us that we had 10 minutes left, so we had our final words, Fredrick told us not to worry about him, he was fine.

And so we left, and spent the journey home reflecting

on the lovely time that we had spent with our dear comrade and friend.

ECAJ asks Attorney-General to streamline racial vilification law**

A delegation from the Executive Council of Australian Jewry has met with Attorney-General Robert McLelland in a bid to review the effectiveness of the Racial Discrimination Act



Quoting the difficulties experienced in bringing Holocaust-denier Dr Fredrick Toben to justice, Peter Wertheim, the newly-appointed Executive Director of the ECAJ and Robin Margo SC the organisation's vice-president told the A-G that it had taken 13 years to finalise this particular case.

The delegation suggested to the Attorney-General that well-founded complaints of racial vilification should be dealt with more effectively. Toben's material had been published on his Adelaide Institute web site. Consequently, the ECAJ has asked the Government to consult with ISP providers in Australia, suggesting to them that they should impose a voluntary code of conduct banning sites found to be promoting racial hatred.

Wertheim and Margo also suggested that the current legislation be amended to allow for the total removal of a website should there be repeated offences. They also submitted that the law be amended to deal with whichever persons were involved in the contravention. Attorney-General McLelland was asked to consider how to deal with international hate sites. It was proposed that any new convention should obligate the individual States to enact legislation to require ISP operators within their borders to ban hate-sites.

ACAJ president Robert Goot told J-Wire: "The Attorney-

General acknowledged that the current law does not always provide a quick and effective remedy. He has welcomed the ECAJ proposals and they will be the subject of a review."

Bomber Harris thought the Dambusters' attacks on Germany 'achieved nothing'

Sir Arthur "Bomber" Harris, the wartime head of Bomber Command, privately dismissed the Dambuster air raids on German dams were a waste of men and aircraft, it has been revealed.

It has gone down in history as the most daring RAF operation of the Second World War. With its mix of heroism and technical ingenuity, the Dambusters Raid became a lasting symbol of Britain's gallant fight against the Nazi regime.

In Winston Churchill's words, the destruction of two key dams in May 1943 brought "unparalleled devastation" to Germany's western industrial heartland. The success of the mission brought widespread public acclaim.

Yet it has now emerged that Air Marshal Sir Arthur "Bomber" Harris, one of the chief architects of the raid, was privately scathing about its effectiveness.

Research in the archives of the Harris papers, stored in the RAF Museum at Hendon, has revealed that he privately thought the assault on German dams was a waste of men and aircraft.

In one letter to the Air Staff, written in Dec 1943, just six months after the raid, Harris said: "For years we have been told that the destruction of the Mohne and Eder dams alone would be a vital blow to Germany." But, he continued, "I have seen nothing in the present circumstances or in the Ministry of Economic Warfare reports to show that the effort was worthwhile." Even as the legend of the Dambusters grew, Harris kept up this disparaging theme.

In a private letter to Sir Charles Portal, the Chief of the Air Staff, written in Jan 1945, Harris complained: "The destruction of the Mohne and Eder dams was to achieve wonders.

"It achieved nothing compared with the effort and the

loss."

He concluded: "The material damage was negligible compared with one small area attack."

The correspondence shows that Harris was just as sceptical about the raid when the plans were initially put forward.

It was Barnes Wallis, the inventor and aeronautical engineer, who in 1942 had come up with the idea that each dam could be breached by a bouncing bomb. Carried by a specially-modified Avro Lancaster, the RAF's new four-engine heavy bomber, the unconventional bomb would leap over the water, reach the dam's thick wall, sink below the surface and then detonate at the optimum depth, thereby unleashing a colossal flood tide into the surrounding area.

Early tests on the bouncing bomb, conducted at Chesil Beach in Dorset, revealed that the scheme was practical. The Air Ministry was quickly won over.

But, as the unpublished documents reveal, Harris was outraged. He thought his precious Lancasters should be allowed to concentrate on Bomber Command's primary task of reducing Germany's cities to rubble.

When first informed of Wallis' proposal by Robert Saundby, his deputy at Bomber Command, in Feb 1943, he produced a scathing denunciation.

The bouncing bomb was "tripe beyond the wildest description. There are so many ifs and buts that there is not the smallest chance of it working."

Harris urged that Air Staff should be stopped from "putting aside Lancasters and reducing our effort on this wild goose chase". The war, he warned, "will be over before it works and it never will".

A few days later, his opposition to the plan had only intensified. In a letter to his superior, Sir Charles Portal, he described the bouncing bomb as "just about the maddest proposition as a weapon we have yet to come across".

Deprecating "any diversion of Lancasters at this critical moment", he told Portal that "I am prepared to bet my shirt" that the bomb could not be produced within six months and "will not work when we have got it".

He hoped that the new weapon's enthusiasts would be "given one aeroplane to go away and play while we get on with the war".

Harris, however, was overruled by Portal, the RAF's chief, who was determined to press ahead with the plan. For all his doubts, the bomber commander had no choice but to obey his orders from the top of Air Staff. To carry out the raid, he formed a new Lancaster squadron, named 617, under the leadership of Wing Commander Guy Gibson, a dynamic, brave and highly experienced pilot.

Meanwhile, the Lancaster aircraft were adapted by the Avro company to carry the special equipment for the bouncing bomb.

The raid took place in bright moonlight on the night of May 16 and into the early hours of May 17.

Harris's claim that the bouncing bomb would fail proved hopelessly unfounded, as the successful breaches of the

Mohne and the Eder led to the widespread destruction of homes, factories, bridges, railways, farmland and energy supplies, though a third dam, on the Sorpe, remained intact.

Contrary to Harris's later arguments, Albert Speer, the German Minister for Armaments, said that raid was "a disaster for us for a number of months".

Germany had to divert 20,000 labourers from building defences in France and Holland into repairing the dams, something that had a significant impact at D-Day.

Gibson won the Victoria Cross and his squadron became national heroes. The raid gave an enormous boost to British morale.

The triumph came at a heavy price, as eight out of 19 Lancasters on the raid were lost and 53 crew men were killed. But, unlike Harris, most of the RAF and the British public believed the sacrifice was worthwhile.

Desecration of a hero: Hands of Churchill statue in Paris painted blood red by protesters blaming him for death of millions

French anti-war campaigners have desecrated a statue of Winston Churchill in Paris on the anniversary of the death of Rudolf Hess.

They daubed the statue's hands in red paint to signify blood and scrawled the initials RH on the plinth.

It has been 22 years since the death of Adolf Hitler's deputy, who flew to Britain at the height of the Second World War, allegedly to try to make peace.

Prime Minister Churchill had him thrown in prison in 1941 and the war continued for four years. After the war Hess was tried at Nuremberg and jailed for life.

The statue was attacked on Monday night, August 17, the day on which in 1987 Hess died at Spandau Prison

in Berlin, aged 93. Some conspiracy theorists believe his suicide by strangulation was in fact an assassination. Among them is the Rense freedom group which has claimed responsibility for the Paris attack. The group wrote on a website: 'Protesters inscribed the initials of Rudolf Hess and daubed the hands of the Winston Churchill in crimson red on the statue of the notorious war criminal in Paris.

'Sir Winston set the stage for the slaughter of millions in World War II, when he refused to hear Hess's proposals for ending that unnecessary conflict.

'Churchill's bloody work was completed when Hess was brutally murdered by agents of Britain's top-secret MI6, acting in collusion with his American captors, at Spandau Fortress prison.'

There was widespread anger at the attack on the statue, which is next to the Champs Elysees.

A spokesman for Paris City Hall said: 'There are French people who are not great fans of Churchill, but the vast majority honour and respect him and will be disgusted by this cowardly attack.

'We presume this must have happened during the night. The paint is being cleared away and the statue restored to its former glory.' The bronze artwork by sculptor Jean Cardot, erected with £250,000 raised by the French people, is one of the few in Paris of a non-French public figure.

It is modeled on a photograph of Churchill marching with France's wartime leader General Charles de Gaulle down the nearby Champs Elysees on 11 November, 1944.

Three months earlier, starting on August 19 1944, mainly American Allied troops coming south west from Normandy swarmed into the French capital, ensuring its liberation.

When the statue was unveiled in 1998 by the Queen, she conceded that 'relations between Churchill and de Gaulle were not always very easy. But they always knew that Great Britain and France had a lot in common.'

The 10ft high statue's plinth bears the immortal words: 'We shall never surrender.'

A Paris police spokesman said such attacks would 'not be tolerated' and that everything would be done to bring the vandals to justice.

I Bear No Hatred By Herbert Schweiger

Must this man go behind bars for having mistaken opinions?



DEUTSCHE STIMME recently spoke with controversial writer and World War II Veteran Herbert Schweiger. Born in Spital/Semmering in Austria's Steiermark in 1924, Schweiger joined the WAFFEN SS (SS = SCHUTZSTAFFEL or "protective echelon", the elite international branch of the German armed forces during

World War II) when he was 17 years old. Following his release from internment as a prisoner of war, he initially joined the VdU (VERBAND DER UNABHÄNGIGEN = Organization of Independent Voters) and then the FPÖ (FREIHEITLICHE PARTEI ÖSTERREICHS = Austrian Freedom Party.)

In 1980, as a member of the Association for the Election of a National German-Austrian he was instrumental in electing a German-Austrian as President.

On several occasions he has been arrested for the crime of WIEDERBETÄTIGUNG (re-activation) of National Socialist opinion.

He is the author of several books.

For many years Schweiger has been a popular guest speaker in Germany and Austria.

His publications include WAHRE DEIN ANTLITZ: POLITIK, LEBENSGESETZE UND DIE ZUKUNFT DES DEUTSCHEN VOLKES (Preserve Your Integrity: Politics, Rules for Living and the Future of the German Nation) in 1963; DEUTSCHLANDS NEUE IDEE: NATIONALES MANIFEST FÜR DEUTSCHLAND & EUROPA (Germany's New Idea: A National Manifesto for Germany and Europe) in 2004; and MYTHOS WAFFEN-SS. MILITÄRISCHE LEISTUNG UND WELTANSCHAULICHES FUNDAMENT EINER EUROPÄISCHEN ELITETRUPPE (The Myth of the Waffen-SS: Feats and Philosophical Foundation of an Elite European Military Branch) in 2007

The Interview

DEUTSCHE STIMME:

Mr. Schweiger, several weeks ago you were tried in Klagenfurt District Court for so-called WIEDERBETÄTIGUNG (revival or reactivation of National Socialist opinion) and sentenced to two years in prison. It is possible that in a few weeks you will have to begin serving your sentence.

With what precisely were you charged – and what do you say to the charges?

SCHWEIGER:

My indictment reads as follows:

"...In consideration of the foregoing, Herbert Schweiger is charged with composing, publishing and distributing the books DEUTSCHLANDS NEUE IDEE. NATIONALES MANIFEST FÜR DEUTSCHLAND UND EUROPA and WAHRE DEIN ANTLITZ – LEBENSGESETZE, POLITIK UND DIE ZUKUNFT DES DEUTSCHEN VOLKES.

It is clear that in his activities as lecturer, he wanted to revitalize and propagate specific aims and goals of the National Socialist German Workers Party in Austria...

He has committed the offense listed in Section 3 of VERBOTSGESETZ both subjectively and objectively." The indictment takes sentences from my books out of context in order to fabricate grounds for silencing me. My "crime" consists of discussing World War II with the present generation, which after more than sixty years of anti German brainwashing has a very sketchy understanding of that War.

As a member of the generation that experienced it, I am able to tell young people what it was really like, and for this reason the powers-that-be feel they must take me out of circulation.

The Germans in Germany are unaware of the extent to which patriotic German Austrians are being persecuted. My whole trial has been a procedure for persecuting loyalty to our VOLK.

In 1996 I was arrested on account of my book DIE EVOLUTION DES WISSENS (The Evolution of Knowledge).

In 1997 I was convicted by the Leoben Court of WIEDERBETÄTIGUNG (Reactrivation) and sentenced to 16 months in prison with a minimum of 4 months before eligibility for parole.

My first convection had been in 1959, when I was jailed for three months on account of lectures I gave in Germany.

In 1962 I assisted the freedom fighters in South Tyrol by sharing my wartime experiences as a sapper with the LEIBSTANDARTE ADOLF HITLER (Hitler's bodyguard) during the War.

We completed demolition exercises, for which I was jailed several weeks.

In 1989 I was jailed several months for writing and circulating the article RECHT AUF WAHRHEIT (The Right to Truth.)

As for my present sentence - I don't have to begin serving it until the Fall.

I told the judge: "Go ahead, lock me up!

My wife is dead, and this way someone will serve me breakfast every morning.

I am looking forward to using the prison library.

In my free time I can write a new book.

After all I have been through, you can't scare me."

[There is very little the System can do to an 85-year-old man who still has his wits and whose will is intact.]

DEUTSCHE STIMME:

Let's talk about your life history.

You volunteered for the WAFFEN-SS and remained with it until the end of the War.

Why did you join the SS, and to what extent did your experiences with this organization form and influence your later life?

SCHWEIGER:

First of all, you would have to understand and be familiar with the defining experiences of my generation, the generation born in the 1920s.

We experienced severe hardship and deprivation in Austria following World War I, as a result of Allied treachery at Versailles.

The victorious powers, you will recall, violated all the assurances they had given the German and Austrian Empires at the time of the Armistice.

There were a million unemployed, of whom a third were the so-called "AUSGESTEUERTE" who received no assistance whatsoever from the State.

They did not get a penny!

It was all they could do to put soup on the table.

When I was a lad, half of my classmates came to school hungry, without breakfast.

A hungry child cannot concentrate on his lessons.

This situation continued until the ANSCHLUß in 1938.

Another factor that influenced the prevailing mood in those days was the anti German policy of clerical Austrian fascism.

After Austria joined the Reich in 1938, the terrible deprivations ended almost immediately.

The VOLKSGEMEINSCHAFTSGEDANKE (concept of ethnic community) provided a basis for solving our national and social problems, and it made us enthusiastic adherents of National Socialism.

Thanks to my personal observations of how National Socialism solved the critical problems of the common people, I too was inspired to become politically active.

I joined the HITLERJUNGEN (Boy Scouts for Hitler) and soon became a leader of 400 youngsters.

For me, the Waffen-SS represented the military and spiritual power of a fresh new movement, a national

renaissance of which I wanted to be part.

Let me emphasize, as a graduate of the Braunschweig JUNKERSCHULE (SS officer candidate school), that WELTANSCHAUUNG (world-view or philosophy of life) was the principal subject we were taught.

I say this in response to the eternal alibi of certain irresolute individuals who insist that we were "soldiers like all the others."

Our head instructor was Konrad Lorenz, who later became a renowned professor and ecologist and Nobel Prize winner.

At that time he was head of the Psychology Department at Königsberg in East Prussia.

It was made very clear to us that we were struggling for the survival of Western Civilization.

Europe's future, if it had a future, depended on our ability to overcome both Bolshevism and the rule of GROSSKAPITAL or "Globalism" as it is now called. Our instructors emphasized that since 1917, Bolshevism had liquidated fifty million peasants, artisans, aristocrats and intellectuals; and that Stalin was propagating world revolution and world conquest as his strategic goal.

The training I received at the Junkerschule has inspired me all my life. Upon graduation I was promoted to SS-

UNTERSTURMFÜHRER (lieutenant) in the First

Pionierkompanie (Sappers) of the First SS-

PANZERDIVISION LEIBSTANDARTE ADOLF HITLER. I began my duties on the Eastern front in July 1941 and was wounded three times, the last time at Plattensee.

The Americans captured me while I was recuperating in a military hospital.

Then it was hands up, tattoo blood type on left arm and straight to the notorious Altheim prison camp. Later I was at Ebensee camp, where after half a year I was able to escape under the barbed wire to relative freedom.

Friedrich Nietzsche has always fascinated me.

He influenced me more than any other philosopher.

Thanks to Nietzsche as well as numerous other Western philosophers beginning with pre-Socratic Greeks I have developed my inner self so that I am able to experience WELTANSCHAUUNG as a kind of religion.

It is not a religion in the sense of a particular confession, but rather a metaphysical connection to a higher plane of existence.

You could say that for me, religion is the worship of Life itself.

The comradeship of the front lines contributed greatly to forming my character, along with my basic political and philosophical convictions,

The realization that we were fighting for the survival of Europe and the Reich against both Bolshevism and Globalism inspired us strongly.

We were bound by a comradeship that today's youth cannot imagine.

[The increasingly international character of Waffen-SS is seldom taken into account.

By the end of the War, most of its members were no longer German.

They came from every country in the world, especially France and Scandinavia.]

After 1945 the puppet government began its vicious attacks on our honor, which we defended as best we could.

After being "liberated" by our enemies, 700,000 German Austrians lost their jobs overnight for having been members of the Party.

Along with other persecuted returnees I became active in the HEIMKEHRER HILFS- UND BETREUUNGSSTELLE

(Organization to Assist Returnees.)

The Verband der Unabhängigen (Association of Independents) and then die Freiheitliche Partei Österreichs (Austrian Freedom Party) then developed from the Heimkehrer Hilfs- und Betreuungsstelle.
DEUTSCHE STIMME:

Your involvement in contemporary politics is not limited to "reactivating National Socialism."

You have published several books dealing with questions of appropriate policies and programs for our time.

Can you briefly outline your idea of the policies that would enable Germany and Europe to cope with the problems of the present?

SCHWEIGER:

The parameters of a scientifically sound world-view are defined by evolution, genetics and behavioral science – that is, VOLK UND RASSE..

There is no such thing as universal equality of mankind. This has nothing to do with value judgments of the relative merits of individual peoples or races, which may be truly great or even unique.

The simple truth is that nations, peoples and races vary greatly in every respect.

Politics and policies are determined by natural laws, not the other way around.

Politics cannot determine natural laws!

This is the demonstrable truth, even though our pathetic and shortsighted politicians keep trying to convince us otherwise.

DEUTSCHE STIMME:

You have experienced the War and postwar period as well as the decades since then.

When you survey such a long period, do you have the feeling that all is lost?

Or, to express the question differently: where can you find hope?

SCHWEIGER:

Our hope is in the younger generation, especially the young people in the former DDR.

[This is because what was called East Germany during the Cold War was less Russianized than West Germany was Americanized, and

the national spirit survived better in the East.

In this respect the former East Germany has been compared to a woman who suffers the eternal fate of women in a conquered land whereas West Germany has been compared to a woman who prostitutes herself.]

The DDR agitation against Capitalism had a positive effect on German youth, despite or because of the collapse of Communism.

Today's youth in the former DDR is nationalist, socialist and anti capitalist, as was my generation [the "Greatest Generation" as American authors like to say.]

Despite formidable difficulties and dangers, I see great opportunities ahead.

DEUTSCHE STIMME:

In concrete terms, what would Germany and Austria have to do in order to be able to offer future generations hope for the future?

SCHWEIGER:

There are real alternatives for Europe as a whole.

The national socialism of the National Socialist German Workers Party has given way to a European-wide movement.

In considering our future prospects, we must consider the biological point of view.

The scientific discoveries of recent years have made it ever more clear that biology is life.

A nation that ignores the laws of life and nature and violates biological imperatives can have no stability in the long run.

It causes its own downfall.

Geopolitically, the only thing that can protect us from demographic inundation by the overwhelming population masses of Asia and Africa is partnership with Russia.

DEUTSCHE STIMME:

As you look back and take stock from the vantage of your long life, do you feel that you have been able to pass on some part of your convictions and legacy?

SCHWEIGER:

Yes, I believe I have.

I have done my utmost for the enlightenment of coming generations with lectures and book publications, which are directed toward the younger public.

DEUTSCHE STIMME:

The last question: what are your sentiments in case the Klagenfurt verdict is upheld and you are compelled to serve your prison sentence?

Do you have any regrets?

SCHWEIGER:

I bear no hatred and I feel no anger.

As individuals, I absolve those who persecute and convict me.

They were born into the Zeitgeist (spirit of the age) that made them what they are.

With no sense of VOLK, they are unable to resist the psychology of occupation, subordination and "multiculturalism" imposed on all Europe by our victorious enemies.

They are all too human!

Whether they suffer from lack of character and intelligence or whether they simply succumb to opportunism, they are unable to escape the dictates of UMERZIEHUNG (Re-education) [or "De-education" as the case may be] that the victors of World War II imposed on us.

I cannot absolve certain judges and prosecutors, however.

This is because our Reich is still occupied both physically and spiritually, in violation of international law.

Some of these judges and prosecutors are actively serving the interests of the occupiers, for their own personal gain.

As for draw a balance and summing up my life - if I could live it over again, I would live it exactly as I have done. I regret none of my choices or actions.

When my father lay on his deathbed he said "I have never been untrue to myself!"

I am able to say the same thing.

Furthermore if a person is able to exhibit a clear countenance ("ANLITZ BEWAHREN") his enemies will respect him.

The greatest mistake one can make is to apologize for a fundamental and deeply held conviction.

In Defence of Dr. Fredrick Toben

(Founder and former director of Adelaide Institute, and the first prisoner of conscience in Australia's legal history.) *by David Brockschmidt*

Truth in History must never be decided in courtrooms. To use the Racial Vilification Act against Dr. Toben - Adelaide Institute by Jeremy Jones, a prominent figure within Jewish-Zionist circles in Australia, is plainly wrong, because Jews are not a race. Australia has other laws to deal with slander and defamation which could have been used by Jeremy Jones if he felt slandered and/or defamed. If the Legal system in Australia includes Jews into a racial category, then Australia indirectly agrees with Adolf Hitler and the National Socialists of Germany who declared and classified Jews as a race. Any anthropologist anywhere in the world, including the State of Israel will state clearly that Jews are not a race. According to the ABC1 Compass program of Sunday, 16th August 2009, 9.35 PM Titled "Mazal Tov, Mazal Tov!" (which means - Good Luck, Good Luck!), let me quote a Rabbi from this program, who said "Judaism is not a religion, and not a culture, but a way of life" This statement surprised me because in my understanding Judaism is indeed a religion and a culture, and not only a way of life. If this Rabbi would be correct, neither the Racial nor the Religious Vilification Act could have been used against Dr Fredrick Toben - Adelaide Institute. In regards to our Toben-Adelaide Institute judgement, let me make the following points: Firstly, as we all know, Justice is blind and so are many politically correct Judges these days. Dr Toben put it into one sentence after these judges were sending him to jail, and denying him a last word. He said loudly and clearly for everyone to hear, addressing the judges on their way out of the courtroom "You are following blind orders Gentlemen". Secondly, The Toben-AI case shows Australia and indeed the World, that Australia has abandoned common Law and common sense. Thirdly, the court procedures against Dr Toben-AI within the last several years, make it crystal clear that there is no freedom of speech, no freedom of scientific and historical research in this country, if this research collides with the taboo mantra of so-called Holocaust studies. These studies are not identical with the research regarding the Shoah. The old Marxist dialectic applies to Holocaust research today in Australia, which is "it cannot be, what is not allowed to be". Anything what does not fit this brave new world order framework, expressed either verbally and/or in print, is classified as hate speech. The law-makers in this country, and indeed the whole Western world, decide what is love and what is hate speech. The rules are simple, hate is what affects the national interest and love is what serves the national interest of the country. Let me give you an example here, Love, is if we go into Afghanistan or Iraq with our freedom loving allies and having a 'smashing time' there. Destroying their infrastructure and loving innocent Afghani and Iraqi civilians to death, plundering their antiquities sites, which means destroying their history. Helping to establish permanent US army and air-force bases. Corrupting the people with pornography and other toxic sludge, produced in our freedom loving Western world, which will one day destroy us too. We all do that because we love Iraq, for example so much, not their people of course, but their oil. Anybody who opposes our 'giant love-in' in Iraq and Afghanistan, not only acts against the national interest of our Nation, but is classified as a Hater and Terrorist sympathiser. To repeat George W Bush's sentence here, who said "If you

are not with us, you are with the terrorists" So what has that to do with the Toben-AI case here? Dr Toben has been classified as a 'Hater', not only by the system Media, employing thousands of conformist intellectual prostitutes, poison-pen artists, and ink-pissers. There are, of course some shining examples within Journalism who have protected their personal and professional integrity, in not prostituting themselves to the media czars worldwide. I am especially thinking here of the British Journalist - Robert Fisk, the Australian Investigative journalist - Chris Masters, and the late Paul Leinem. Also John Pilger, and Greg Palast come to mind. Classifying Dr Toben as a 'Hater' surprises me also personally because the feedback that I got when he was still teaching was that he loved his work, he was a good educator- teacher with a good sense of humour. Dr Toben hold two BA's and a Doctorate in Philosophy. He has not only taught in Australia, but in other parts of the World, visited and worked in many countries, including the State of Israel, and taught for a lengthy period in Nigeria. When he asked his students in Nigeria what they thought about corruption in their country, one student answered " Sir, yes we have corruption here in Nigeria. The difference between ours, and your corruption is simple. Your corruption is more sophisticated than ours. You are not only financially corrupt but morally and intellectually too. Your corruption is driven by your greed for money and by the plundering of our resources. Our corruption is based on poverty caused by your ruthless exploitation of our workforce and our country as a whole. Every dollar you invest in our country, you make sure you get three to four dollars back, Sir. This imprisons us in your debt-trap which is based on your usury, speculation and financial system. We are not as cunning and conniving as you are Sir. But don't worry Sir, Africans, at least us Nigerians are fast learners. One day we will beat you at your own game. This is the eternal law of Karma." Lets go back to the Toben-AI case, thanks to the three Federal Court Judges, Dr Toben has now checked-in to Hotel Yatala, South Australia's University of crime, proudly sponsored by the government of South Australia. Let's hope that Dr Toben will lecture revisionist history to the other 'guests' because every thinking person must revise in order to find out what is the Truth, and what are Lies. It is always said that Dr Toben is not in jail because of his beliefs, his research and his studies of history, but for his contempt of court. That of course in my honest opinion is utter nonsense. The World knows why Dr Toben is in jail ! I personally have also a problem with giving unlimited respect to our legal system and our courts, which of course includes the judges. When the whole legal actions against Dr Toben started, in front of the Human Rights and Equal Opportunities Commission in South Australia, Dr Toben asked the then Commissioner Kathleen McEvoy, "Is truth a defence in my case here?". The Commissioner answered, "Not Necessarily". This left me speechless, because if truth is no defence, then the system is morally bankrupt. It is B.E.A as we said in the army, which means Beyond Economical Repair, ready for the scrap heap. So we might as well call HREOC - O'HREOC which means, the Orwellian Human Rights and Equal Opportunities Commission. As George Orwell said in his brilliant book, 1984, "Truth telling is always a revolutionary act." Last, but not least, let me comment on Dr Toben's critique regarding our legal system and the rule of law in

Australia. Let's see if his critique has some merit. Very few Judges apply the principle of Common Law today. It is generally agreed that the legal system in this country has failed the people of Australia, Justice is blind and indeed so are more and more Judges today. It seems that these Judges are totally disconnected from the realities of real life. Their judgements are sometimes very strange indeed. this raises the question, are these judges living in a different world than us?, or are they completely off the Planet?

Judges are supposed to uphold the rule of Law, but more and more exceptions are made here. Judges allow tribal law to be applied in disputes between Aboriginal people, for example.

Dr Toben's accusation, that Judges and the legal system in this country are influenced and infiltrated by powerful Jewish-Zionist groups needs some closer examination. Dr Toben believed that some judges in South Australia have lost their independence. According to Dr Toben, they still uphold the rule of Law, but it is not the law of the land, but Talmudic Law, the religious Law of Judaism. Let's hope that Dr Toben is wrong here, because according to Talmudic Law we Gentiles are not even classified as Human beings, but as animals. So, if Dr Toben is right, and we are ruled by Talmudic Law, then we might change the name of this country from the Commonwealth of Australia, to Talmudistan. We also have to make sure that our legal counsels representing us in case of conflict come from the Animal Rights movement.

The laws of the Commonwealth of Australia based on the Westminster system, must never ever be replaced, nor supplemented with any tribal and/or religious laws, for example Talmudic Law and/or Sharia Law. If we want to survive as a nation which is united, we must stop the erosion of common law and Habeas Corpus in Australia, otherwise it makes the law of the land look like Swiss cheese. How far we have gone down this road of legal spiritual and intellectual self destruction, is shown in two articles entitled: "What! Jewish Law comes first?" by Betty Luks, and "The legal system out of control?" by Ian Wilson LL.B

Dear reader, after reading these two articles, you make up your own mind, if Dr Toben is right or wrong here. The walls which incarcerate Dr Toben now, will come down like the Berlin Wall has come down. Political correctness which is nothing else but intellectual terrorism, according to Dame Leonie Kramer, will disappear. The walls of fear have come down already. Leaders pay attention, the masses are becoming restless and angry. Globalism will end up where it belongs- onto the scrap heap of History. Cadell Training is located approximately 180 km north-east of Adelaide and is situated on the River Murray 10 km from Morgan.

Cadell accommodates up to 167 low security male prisoners in various styles of accommodation including a cellblock, cottages and a dormitory. Cadell Training Centre does not have a secure parameter fence and prisoners are at Cadell under their own trust.

Cadell promotes a drug free environment for prisoners with over fifty percent of it's prison population housed in Drug Free Cottage accommodation. Prisoners living in these independent living areas develop life skills and have extra privileges available to them. Selected prisoners are able to join the local CFS and/or the Community Work Unit.

A significant focus for Cadell Training Centre is in the area of Restorative Justice. Prisoners undertake and have completed many community work projects including local cemetery upgrades, painting and restoring Scout Hall, RSL Hall, Football Club Rooms and development of the new Cadell Oval Building Upgrade and Campground Construction in association with the Cadell Community & Tourist Association.

At Cadell Training Centre prisoners take part in a structured day. All prisoners work either on the prison farm where the focus is dairy production and packaging, citrus and the new development area of olives or in the prison service areas where prisoners can participate in maintenance, kitchen, laundry, grounds or servery work. Cadell Training Centre's newest focus is REACHOUT a program that targets and addresses young offenders with drug and alcohol problems. The program is partnered with OAR SA and is expected to run for two years.
